## TERMS AND CONDITIONS

**GENERAL POLICY:**

We sell only to legitimate powersports businesses (licensed places of business, open to the public during normal business hours, and serving the public in areas of powersports sales, service and/or parts and accessories).

**TERMS: CREDIT CARD**

All purchases must be prepaid by Visa, Mastercard, American Express, or Discover to Seven Springs Sales, LLC. Credit Card information will be collected upon initial order.

**SHIPMENT:**

Items are generally shipped via UPS Ground unless otherwise specified. We assume no responsibility beyond delivery to carrier in good order and are not responsible for loss, damage, or delay occurring thereafter. We will ship by the most reasonable means according to the size and weight of your order unless given special instructions.

**DAMAGES:**

All goods are carefully packed and in good condition when shipped. Claims must be made with the carrier, not with Pro-Wheel Racing Components. Please note the number of packages delivered as sometimes they will be separated by the carrier.

**RETURNS:**

All sales are final except for defects in manufacturing or shipping errors. If you receive product by mistake or the improper quantity, a UPS call tag will be issued for pick up. A full credit for the amount of the product and shipping will be issued after the product is returned to Pro-Wheel Racing Components. Do not return merchandise without prior approval. Returned merchandise must be accompanied by a return authorization or merchandise will be refused and returned to customer. Returns for any reason other than shipping errors must be sent prepaid.

**PRICES:**

We reserve the right to modify prices without notice and to bill at the prevailing price at the time of shipment. Always check invoice for cost.

**SERVICE:**

Prompt service is of primary consideration. Every effort will be made to ship an order the same day it is received. Next day, 2-day, and 3-day shipping orders must be received no later than 1:00pm Pacific Time to guarantee same day shipping.

**BACK ORDERS:**

We will keep all backorders in the system unless otherwise specified. We will attempt to call before shipping any backorder items. Your order will automatically be cancelled if you do not reply within 48 hours as to whether or not you still wish to receive your backordered items.

**WARRANTY:**

There is no implied, oral, or written warranty on our products. However, if you are not fully satisfied, or believe you received a defective item, we will work with you on a case by case basis to correct the situation.

**GENERAL PROVISIONS:**

- (a) These terms govern all sales, and may not be changed except with our written consent.
- (b) THERE ARE NO WARRANTIES, EITHER WRITTEN, ORAL, IMPLIED OR STATUTORY, RELATING TO THE GOODS SOLD TO BUYER BY US AND NO IMPLIED STATUTORY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL APPLY.
- (c) We shall not be responsible for any damage to person or property arising from the design, manufacture and testing of our products, and we accept no liability for such damages.
- (d) We shall not, under any circumstances, be liable for any labor charges without our prior written consent. We shall not in any event be liable, whether as a result of breach of contract, warranty, tort (including negligence), or other grounds, for special, consequential, incidental, or penal damages including, but not limited to, loss of profits or revenue, or claims of customers of the buyer of such damages.
- (e) If legal action is used to collect a past due account, we shall be entitled to recover reasonable attorney's fees and costs.
- (f) A counterpart of this document delivered by facsimile transmission shall be deemed an original counterpart for all purposes.
